

'GO ELECTRIC' TOUR SWEEPSTAKES OFFICIAL RULES & REGULATIONS

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE ENTRANT'S ODDS OF WINNING.

SWEEPSTAKES PERIOD: The 'Go Electric' Tour Sweepstakes ("Sweepstakes") starts on May 17, 2021 at 12:00 AM Pacific Time and closes on June 14, 2021 at 11:59 PM Pacific Time ("Sweepstakes Period").

SWEEPSTAKES SPONSOR: The Sweepstakes is sponsored by Silicon Valley Clean Energy (SVCE), which has its corporate headquarters at 333 W. El Camino Real, Ste. 330, Sunnyvale, CA 94087 ("Sponsor"). Enervee, which has its corporate headquarters at 10000 Washington Blvd, 6th Floor, Culver City, CA 90232 has been retained by the Sponsor to administer the Sweepstakes. Enervee and Sponsor are responsible for the delivery of the Prize(s) to the winner(s). Sponsor's computer is the official time-keeping device for the Sweepstakes.

ELIGIBILITY: This Sweepstakes is open to all customers of SVCE who are 18 years of age or older and a legal resident of the U.S. at the time of entry into the Sweepstakes ("Entrants"). Entrants must be a customer of SVCE prior to the start of the Sweepstakes on [date]. Only one Entrant per SVCE customer account is allowed. Employees, agents and representatives of the Sponsor and its subsidiaries and affiliates, Enervee and its subsidiaries or affiliates and each of their respective advertising and promotion agencies are not eligible to win, nor are the parents, siblings and children of any such employee, agent or representative or any person with whom such employee, agent or representative is domiciled. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

PRIZES: An electronic drawing will be held on June 21, 2021. Each prize (each a "Prize" and collectively the "Prizes") consists of a Two Hundred Fifty Dollar (\$250) on-bill credit for the Entrant's electricity bill or Two Hundred Fifty Dollar (\$250) gift card via Tango. Fifteen (15) Prizes will be awarded.

The Prizes are worth a total of Three Thousand Seven Hundred Fifty Dollars (\$3,750). Entrants are only eligible to win one (1) Prize (e.g., an Entrant is eligible to win only one (1) \$250 gift card or on-bill credit, not fifteen (15)). Entrants can elect whether they would like to receive a \$250 gift card via Tango or \$250 off their electricity bill for their Prize. Prize winners will not be eligible for future Sponsor sweepstakes for one year from date of award. Sponsor reserves the right to substitute any Prize for one of equal or greater value if the designated Prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with Prize receipt and/or use.

SWEEPSTAKES ODDS: The odds of winning each Prize depend on the number of eligible entries received. The odds of an entry winning any Prize will be the same for any method of entry.

HOW TO ENTER: NO PURCHASE NECESSARY TO ENTER OR WIN. Visit appliances.svcleanenergy.org and opt-in to the Sweepstakes by submitting your name and email. Entrants will automatically receive one (1) entry into the Sweepstakes drawing for such submission.

ADDITIONAL METHODS OF SWEEPSTAKES ENTRY. Entrants may increase their number of entries in the Sweepstakes by completing any or all of the following actions during the Sweepstakes Period. Each method of Sweepstakes entry may only be used once by Entrant.

6. Visit the SVCE Solar+Battery Assistant at solarbattery.svcleanenergy.org to receive four (4) entries into the Sweepstakes.

7. Answer one (1) survey question to receive four (4) entries into the Sweepstakes.

All entries shall become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, or misdirected entries, which will be disqualified.

Submitting an entry through mail does not provide any advantage over submitting an entry through the online platform and submitting an entry through the online platform does not provide any advantage over submitting an entry via mail.

There is a total limit of thirty-four (34) entries per Entrant during the Sweepstakes Period using all methods of entry. Different Entrants are not permitted to share the same email address. Any attempt by an Entrant to enter the Sweepstakes using multiple/different email addresses, identities, registrations and logins, or any other methods will void that Entrant's entries and that Entrant will be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the Entrant. Each potential winner may be required to show proof of being an authorized account holder.

AWARD OF PRIZES: Winners will be notified by email within fifteen (15) days of the applicable drawing. Prizes will be awarded only on verification by Enervee and Sponsor that all Sweepstakes requirements have been met by the winners. Each Prize must be accepted as awarded and no substitution, transfer, conversion or assignment of Prizes will be allowed, except at the discretion of the Sponsor, who may substitute a Prize of comparable or greater value. The winner will have seven (7) calendar days from notification to accept the Prize by email. Sponsor and Enervee are not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify the winner. If a selected winner cannot be contacted within the allotted time Sponsor and Enervee reserve the right to void that entry and select another winner for that Prize by random drawing. In order to be declared an official winner, the selected Entrant must complete, sign and return to Enervee a Declaration and Release Form within seven (7) days of receipt. If a selected winner fails to complete, sign and return the Declaration and Release Form to Enervee within seven (7) days the Sponsor reserves the right to void that entry and select another eligible Entrant for that Prize. By completing, signing and returning the Declaration and Release Form, the Entrant (i) confirms compliance with these Official Sweepstakes Rules and Regulations, (ii) releases and forever
