Proposal Addendum Guidelines

Note to Proposers who have submitted proposals already by the original deadline of August 7, 2023: SVCE has extended the proposal deadline as noted on the Cover Page and Page 2 of this Addendum No. 2. Proposers who have already submitted proposals as of August 7, 2023, need not re-submit their proposals. SVCE will evaluate the previously submitted proposals. However, you are invited to submit an **optional** addendum to your proposal, if so desired, to **solicitations@svcleanenergy.org** by 5 p.m. on September 18, 2023.

If submitting a Proposal Addendum, please follow these guidelines:

- Label the addendum clearly on the cover page with:
 - o your firm name
 - your primary contact information
 - o RFP Subject Areas covered
 - o the word "ADDENDUM"
 - date of submittal of addendum
- Please do not repeat any information already submitted in your initial proposal.
 Rather, the addendum can be used for any additional information not covered in the initial proposal.

- Addendum is limited to maximum 6 pages and can be used to add information to any of the Parts within RFP Section 5 Proposal Submittal, except Part 6 – Cost Proposal.
- For revisions to Part 6 Cost Proposal, please re-submit the entire Cost Proposal with a clear note asking SVCE to disregard the Cost Proposal submitted by your firm in the initial proposal. No additional pages are allowed for the Cost Proposal i.e., it must be limited to 4 pages with the 6-page limit for the addendum.

The Addendum is to add to the narrative document of your proposal. Please do not submit a revised slide deck.

For Proposers who have not previously submitted a proposal prior to August 7: Please use the final page limits for each proposal section as indicated below.

Note that this includes the changes to page limits already reflected in Addendum No. 1 (shown in green).

- 1. Administrative Information (1/2 page)
- 2. Proposal summary (1 page)
- 3. Proposer description and qualifications (4 pages)
- 4. Proposed solution (5 pages if covering a single subject area; 10 pages if covering both Subject Areas; up to 10 additional pages covering content in response to this part for Subject Areas A or B or both may be provided in the proposal Appendix with clear page labeling to indicate they are part of Section 5, Part 4))
- 5. Proposed work plan and schedule (1 page) see Exhibit C for format
- 6. Cost proposal (2 pages 4 pages) see Exhibit D of this RFP for format
- 7. Confirmation of acceptance of contract terms or explanation of proposed contract modifications see Section 7 of this RFP (as many pages as necessary)
- 8. Inclusion of non-participating agencies (1/2 page)
- 9. Appendix (does not count towards page limit)
- 10. Addendum (6 pages) covering additional information not covered in any of the previous sections. Please follow the "Proposal Addendum Guidelines" shown on page 3 of this Addendum No. 2.
